

Redding Rancheria Education Department- Johnson O'Malley 2016-17 School Supply Assistance Requirements & Application

Eligibility Requirements:

1. Completed Application

2. Must reside in the Redding Rancheria Service Area

The Redding Rancheria service area is defined as all of Trinity County, From and including the City of Redding to the Siskiyou County line, from and including the City of Redding to the Tehama County line, including Cottonwood and those with Cottonwood addresses, from and including the City of Redding to the Round Mountain to and all those with Round Mountain addresses, and from the City of Redding to Shingletown and all those with Shingletown addresses.

3. School Age Children 3 years to 17 years old and Grades Pre-School thru 12th grade

*(**Preschool students MUST have proof of enrollment in school for FALL 2016-NO EXCEPTIONS)*

4. Native American- Must provide proof of Native American Status

5. Proof of Legal Custody or Guardianship of all children applying (Only if this applies to your household)

6. Court House Birth Certificates (not Hospital) for all children applying

7. Applicant's State or Government Issued Photo ID

Applicant is defined as the Parent or Legal Guardian of the children applying for assistance
